- Trade Creation and Diversion
- Investment Creation and Diversion
- "Hub and Spoke" issues
- Terms of Trade Effects → Trade Wars?
- Potential Conflict
- Trade Facilitation
- "Spaghetti Bowl" problems
- Rules of origin

Attractions of PTAs

- go further, faster
- political economy
- binding commitments
- forum for resolving difficult issues
- training ground
- regional public goods
- locking in reforms
- political and security objectives

Some conclusions from 40 quantitative studies

- Gains
 - APEC > ASEAN + 3 > ASEAN + 1 > bilaterals
- Small/medium economies usually (not always) gain substantially from PTAs with "large" partners
- Expansion of existing PTAs to include new members tends to erode benefits of the existing members (esp. the smaller members)

- Gains to members ("ins") generally (not always) accompanied by losses for excluded economies ("outs")
 - losses concentrated on "outs" that trade intensively with "ins"
 - larger blocs impose larger losses on these "outs"
 - suggestion in some studies that negative impact on "outs" may be mitigated by "new age" elements or productivity growth
- Studies of individual PTAs can produce widely differing (sometimes contradictory) results
 - e.g. US-Australia
 Japan-Korea

Key Question

 How to make the transition from a "kaleidoscope" of PTAs to achievement of APEC's "Bogor goals?

 Conclusion: cannot be assured without deliberate coordinated action by APEC economies

Possible Routes

- Expansion of bilaterals
- Amalgamation and expansion
- Convergence
- MFN liberalisation

Issues

- "Competitive Liberalisation" and the "Domino Effect"
- Effect on Incentives for Multilateral Liberalisation
- Treatment of Sensitive Sectors
- Inconsistent "Models"
- WTO Consistency
- Politics

CONCLUSION: Route to Bogor via PTAs is not automatic
